

#### Overview of 2020-21

#### Inquests

Whilst 2020 saw the largest number of registered deaths in England actually reported to coroners (the lowest since 1995). The 2020 Coroners' statistics document suggests this is "likely a function of the numbers of registered deaths caused by Covid-19 infection, the majority of which will have been of natural cause".
